Introduction

Staff received notification that Niko’s Grill & Pub, Inc. will no longer be operating at 11900 Freeman Road. Niko’s Grill & Pub was approved for a Class “A” license and the license has been returned to the Clerk’s Office.

Staff Analysis

The Liquor Commission is requested to amend the Village of Huntley Liquor Code of Ordinances to reduce the number of available Class “A” liquor licenses appropriately. Currently there are nine (9) Class “A” liquor license holders. The amendment is being requested to reduce the number of Class “A” licenses from nine (9) to eight (8). The Village should not have any vacant liquor licenses available. As qualified applicants request a liquor license, licenses then can be added as needed.

**AN AMENDMENT TO THE VILLAGE OF HUNTLEY LIQUOR
CONTROL ORDINANCE SECTION 110.24 – LIMITATION ON LICENSES
REPEALING ONE CLASS “A” LICENSE**

Ordinance (O)2011-10.45

WHEREAS, the Village of Huntley regulates the sale of alcoholic beverages in the Village through its Liquor Control Ordinance; and

WHEREAS, said Liquor Control Ordinance provides for the issuance of certain classes of liquor licenses and establishes the number of licenses available in each class; and

WHEREAS, Niko’s Grill & Pub, Inc. has surrendered their Class “A” liquor license that was issued by the Village of Huntley on April 28, 2011.

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF HUNTLEY as follows:

SECTION I: The Liquor Commission accepts the surrender of the Class “A” liquor license issued to Niko’s Grill & Pub, Inc.

SECTION II: Section 110.24(A) of the Village of Huntley Liquor Control Ordinance is amended to reduce the number of Class “A” liquor licenses from nine to eight.

SECTION III: All other provisions of the Village of Huntley Liquor Control Ordinance not otherwise in conflict herewith shall remain in full force and effect.

SECTION IV: This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.

SECTION V: All ordinances and parts of ordinances in conflict herewith are hereby repealed.
