#### Huntley Police Department Releases Fourth of July Enforcement Numbers

Huntley, IL – Huntley Police took the following traffic enforcement actions during the recent Fourth of July "Drive Sober or Get Pulled Over" and "Click It or Ticket" safety campaigns:
